### Class Projects Involving Human Subjects<sup>1</sup>

An introductory exposure to the process of conducting ethical research is an important part of students' education in many academic disciplines. The SAGU Institutional Review Board (IRB) desires to partner with course instructors to train students how to conduct ethical research. The following guidelines for teaching research will facilitate that training.

### Responsibility of the Course Instructor

Research-methodology course instructors at SAGU must embrace a common framework for teaching ethical conduct during research. Therefore, all research methodology instructors and all undergraduate and graduate students enrolled in those courses should complete the online course entitled "Protection of Human Research Participants" offered by the National Institute of Health.

Research-methodology course instructors are responsible for communicating three principles of ethical human-subjects research: respect for persons, beneficence, and justice. Specific topics that should be addressed in such courses include (1) equitable selection of research volunteers, (2) informed consent (including the risks and benefits of participation), and (3) confidentiality of research data.

### **Criteria for Avoiding IRB Review**

Research activities that are part of a course requirement and which require the involvement of human subjects **may** not require IRB review and approval. If **all** of the following criteria apply to a class project, IRB review and approval are not necessary:

- 1. The activity is designed for learning purposes only.
- 2. The results will not be made public through presentation outside of the classroom; specifically, the results will not be published in any form or publically presented (e.g., at a state or regional meeting of discipline-specific professionals). A capstone or project paper housed only in the sponsoring department for academic purposes is not considered publically accessible.
- 3. The activity involves procedure with no more than minimal risk. (The phrase "minimal risk" is defined in the following section.) By definition, research of a sensitive topic or requiring the participation of those in a "vulnerable" population cannot be consider a minimal-risk study.
- 4. Informed consent procedures are used during the data-collection process. (Some surveys or observational activities may require disclosure of the procedures used, instead of signature-based informed consent, or no consent at all.) See appendices A, B, and C for sample informed consent templates for three distinct research methods.

5. Data obtained during a research effort will not be identifiable in print or in any subsequent discussion or presentation of the findings. Identifiable data will be completely destroyed or purged at the end of the semester. Note that photographs, video and audiotaped recordings all contain identifiable data.

#### **Definition of Minimal Risk**

Minimal-risk course-based research activities do not require IRB review. *Minimal risk* is defined in the Code of Federal Regulations thus: "the probability and magnitude of harm or discomfort anticipated in the research are not greater in and of themselves than those ordinarily encountered in daily life or during the performance of routine physical or psychological examinations or tests."<sup>3</sup>

The course instructor must determine if the learning activity meets the definition of minimum risk. If a class research activity exceeds minimal risk for the participants, as indicated by failure to satisfy one or more of the five criteria above, the instructor should contact the IRB for assistance at irb@sagu.edu. Examples of minimal-risk include the following:

- 1. An observational study of a given research variable at a public venue
- 2. An anonymous "on-the-street" opinion poll (with adults) about a non-sensitive topics
- 3. A social experiment assessing the differences in preferred interpersonal space or distance between two people engaged in a conversation

#### **Course Projects not Meeting the Five Criteria**

Class projects not meeting ALL criteria listed above must submit the project to the IRB for review.<sup>1</sup>

The following steps must be takes when submitting a research activity for IRB approval.

- 1. Complete and submit the IRB Application form for course-based research projects. Note that the instructor is the Principal Investigator
- 2. Complete the Application Checklist to ensure that all required information is included.
- 3. Attach as appendices to the Application all essential supplemental documents, including:
  - The Protection of Human Research Participants course completion certificate (for both the instructor and the students completing the study)
  - Informed Consent document(s)
  - Copy of all surveys/questionnaires to be used (if applicable)

The IRB review process typically takes between two and four weeks. Please contact the IRB (irb@sagu.edu or Dr. Marvin Gilbert @ extension 5495) with any questions or concerns about this document or a particular instructional activity.
