| 2.        | <b>LETTER:</b> Submit a detailed letter that explains the circumstances that have caused an income reduction. Be as detailed as possible because we need to know exactly what has occurred to cause a change in your family's financial situation. | 3.        | <u>DOCUMENTATION:</u> Based on your situation, Nelson University must collect certain documentation. | Do<br>inc | Loss of employment or drastic change in income ocumentation Needed: Your letter referenced in #2 above should specifically list who lost their job or had a drastic change in some. You should state if that person is receiving unemployment compensation, when the loss occurred and provide porf of job loss (letter from HR department, final pay stub, etc.)  |
| Do        | <b>Divorce or separation</b> cumentation Needed: Your letter referenced in #2 above should list the date of divorce or separation. You must submit a py of the divorce decree or the divorce petition verifying separation or document expenses from two households.   |
|           | Death of parent or spouse ocumentation Needed: Submit a copy of the death certificate.   |
| Do        | Extremely high expenses (medical, natural disaster, etc.) cumentation Needed: Your letter referenced in #2 above should list the specifics of your situation. You must submit cumentation showing the expenses that have been paid out of pocket and not covered by insurance (submit receipts, etc.)  |
| Do        | Dependent student has gotten married since submitting FAFSA ocumentation Needed: You will have to submit a Verification Worksheet, tax return transcripts for student and spouse and a py of the marriage license.   |
| Do        | 2024 taxes on FAFSA had unusually high income ocumentation Needed: You must submit documentation that identifies the source of income and how funds were spent or vested and why they are not available as a resource for the upcoming year.   |
